Dear Parents and Caregivers,

Re: 2026 School Charges

At Pompallier Catholic College we are committed to providing our students with resources and activities that will enhance learning opportunities.

We will be in the Government 'School Donation Scheme' for the 2026 year. Being part of this scheme means that there are curriculum-related donations that we cannot ask for.

You can find out more about the scheme on the Ministry of Education website https://www.education.govt.nz/ (search "What families/whānau need to know about school/kura donations").

The college is still able to request donations towards overnight camps. There are also compulsory charges for take-home items in technology and arts classes, and for activities such as sports, extra-curricular, and school retreats and trips.

The Attendance Dues portion of the account is compulsory and collected on behalf of the school's Proprietor (refer to explanation below).

To assist you in understanding how the annual account is calculated, we have explained the various charges below.

We are mindful of the cost of school charges, so are happy for families to pay their account by **regular** automatic payments throughout the year (and in-line with the school terms). NOTE: For students who will be new to our college in 2026, parents/caregivers will receive their first statement within the first few weeks of the school year. The deposit of \$200.00 that you paid in 2025 to secure your child's place will show as a credit towards the 2026 Attendance Dues.

Attendance Dues

Attendance Dues are a compulsory payment under the terms of the Education and Training Act 2020, and a condition of enrolment at Pompallier Catholic College. Attendance Dues are charged for all students who attend Catholic Schools in New Zealand.

Attendance Dues are used to repay loans for building works done at schools in the Auckland Diocese, property related costs including school building works, buildings insurance and costs directly associated with the administration of Attendance Dues.

Attendance Dues are collected by Pompallier Catholic College on behalf of the school's proprietor, the Roman Catholic Bishop of Auckland. The Attendance Dues collected by Pompallier Catholic College are forwarded to Auckland Common Fund Limited, a company established by the proprietors of Catholic integrated schools in the Diocese of Auckland responsible for the collection of Attendance Dues.

Note: We remind families that payment of Attendance Dues is a condition of enrolment and attendance, and the Auckland Diocese can discontinue attendance of a student in default of this undertaking.

Special Catholic Character Contribution*

The Catholic Special Character contribution is a donation of \$70.00 per annum, per student.

This contribution provides the main source of funding for all services provided to Pompallier Catholic College by the Catholic Education Services Board. No contributions are made by the Government for these services.

The Catholic Education Services Board assists schools to provide a Catholic education for your child through the preservation and enhancement of the Catholic Special Character in our schools.

National Marist Network Trust*

This donation is used for funding and promoting Marist initiatives throughout New Zealand, such as Marist Youth Leaders, Marist Neighbours, and staff professional development. We are also lucky to have a team of dedicated young adults from this network who work with our students, running retreats at Pompallier Catholic College.

Pompallier Building Development Donation*

This donation is used for property maintenance and enhancement within our college.

* All **voluntary donations** made to the college are tax deductible and a refund of up to 33% of your donation may be claimed from the Inland Revenue Department. *A tax donation certificate will be automatically emailed to you in early April each year.*
